Sub: Interim relief to SEZ units in lease rent on account of COVID-19 outbreak-reg.

Attention is invited to the MOC&I, Department of Commerce letter No. K-43014(16)/5/2020-SEZ, dated 11.05.2020 regarding Interim relief to SEZ units in lease rent on account of COVID-19 outbreak (copy enclosed).

It is to inform that, the MOC&I, Department of Commerce has examined the proposal in consultation with Department of Expenditure and decided following relief for SEZ units on account of COVID-19 outbreak:

- A) No increase in lease rent for the SEZ units for the FY 2020-21.
- B) Payment of lease rent of first quarter is to be deferred upto 31st July, for all SEZ units. The deferment may not invite any interest thereof.

Therefore, it is decided that there shall be no increase in lease rent for the units in SEEPZ, SEZ for FY 2020-21 and the lease rent for first quarter of FY 2020-21 is deferred till 31st July 2020 without any interest.

Further, all developers (State govt./ Private) under office of Development Commissioner, SEEPZ-SEZ are requested to extend above said relief to their SEZ units as a measure to support the trade in the Covid-19 pandemic.

Sir,


I am directed to refer to DoC's letter of even number dated 11th May, 2020 (copy enclosed) on the subject cited above and requests for further clarification.
