

2 Keeping in view the shortage of Chartered Engineers available for valuation of second hand machinery/goods which are over and above Pre-Shipment Inspection Agencies (PSIAs) notified by DGFT and also to ensure uniformity of practice of valuation/examination in Entire Delhi Customs Zone, Public Notice No. 09/2019 dated 20.03.2019 was issued by this commissionerate inviting applications for empanelment of Chartered Engineers for examination/valuation of second hand machinery/goods in the jurisdiction of Commissioner of Customs, ACC (Import), New Customs House, New Delhi. Further, in Public Notice No. 12/2020 dated 02.03.2020 it has been provided that process of empanelment has been initiated and in the meantime, valuation of second hand machinery will continue in the manner as prescribed in Public Notice No. 08/2018 dated 15.03.2018.

3. Pursuant to Public Notice No. 09/2019 dated 20.03.2019, applications were received for empanelment as Chartered Engineer. The applications were scrutinized by a Committee constituted for finalization of empanelment of Chartered Engineer and it was referred to the Institute of Chartered Engineer (Kolkata) in terms of Para (4) of the Public Notice No. 09/2019 dated 20.03.2019 issued by this Commissionerate for verification of the eligibility to evaluate second hand/used machinery etc.
4. After taking into consideration all the facts, it has been decided to empanel fifteen Chartered Engineers as per Annexure "A" to facilitate the trade regarding examination and valuation of old and used machinery. This panel will be valid for one year from the date of issuance of this Public Notice. The Trade may contact the Chartered Engineers from the list as mentioned in Annexure "A" to this Public Notice for their Customs related work.
5. The guidelines, as provided in Public Notice No.12/2020 dated 02.03.2020 are to be strictly adhered to by all the stakeholders. It is reiterated that where a Chartered Engineer's certificate is required, the choice of the Chartered Engineer from amongst the empanelled Chartered Engineers, shall rest with the importer. The fees for hiring the services of the Chartered Engineer shall be borne by the importer.
6. In case the proper officer has any doubt regarding the accuracy of the evaluation by the Chartered Engineer or if the valuation is done by a Chartered Engineer, who is not qualified in the relevant field to appraise the particular consignment, the same will be referred to another Chartered Engineer.
7. The empanelled Chartered Engineer(s) conducting examination and valuation of the old and used machinery imported through this port are required to submit yearly self appraisal report in the format prescribed in Annexure-B to this Public Notice, to the Additional Commissioner of Customs (Technical), ACC (Import), Delhi before 31st December of every year.
8. If any empanelled Chartered Engineer is found to be involved in any offence related to classification, valuation etc. under the provisions of the Customs Act, 1962 or not adhering to the rules and regulations as laid down, their empanelment would be withdrawn and appropriate action would be initiated against them under the provisions of the Customs Act, 1962.
9. All Trade Associations/Members of Customs Brokers Association are requested to take note and publicize the contents of this Public Notice among their members/constituents.
10. For the departmental officers, this may be treated as Standing Order.


