

Important Instructions

- Before start the application, following points to be kept in mind:-
 - Exporter must have the Digital Signature Certificate containing IEC available with them and install the DSC software in the system available in the digital key.
 - Must Install Java in the system if not available using any web browser (Chrome, Mozilla Firefox, IE etc).
 - After installing java, Go to the program menu and search “configure java” and open.
 - Redirect to Security → Edit Site List → Click Add → Type “http://14.143.90.243/” and click Add → Click Ok.
- Open the browser and enter the URL as “http://14.143.90.243/”.



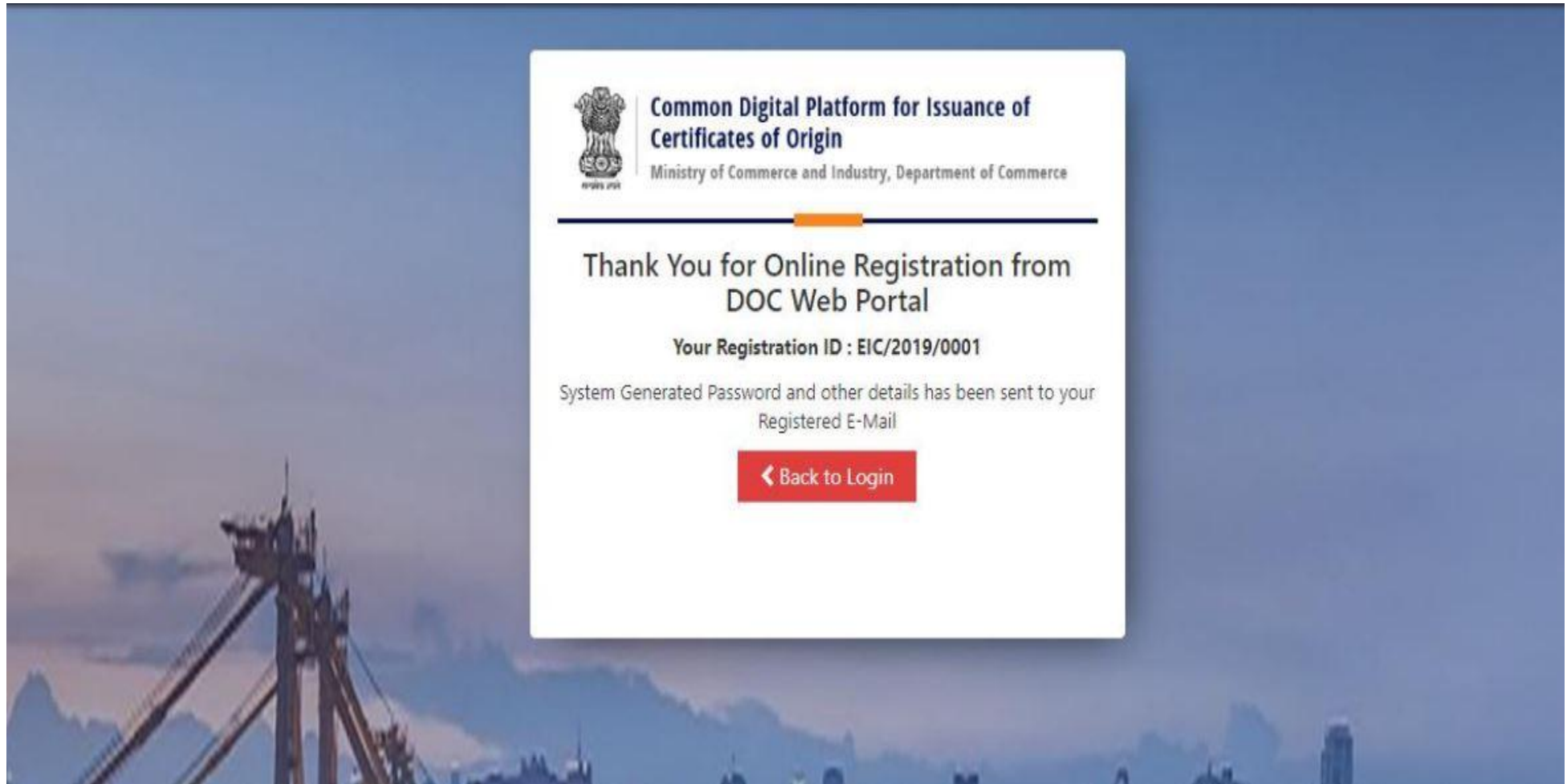
