**PUBLIC NOTICE NO. 10 /2023**

The attention of all Importers, Customs Brokers, Members of Trade and all concerned is invited to the exercise NTRS 2023, following which it has been observed that non-submission of documents and uploading of the same in e-sanchit at the time of filing of Bills of Entry is leading to substantial increase in dwell time in both facilitated and non-facilitated Bills of Entry.

2. In this regard, it is to add that compliance requirements with respect to the Legal Metrology (Packaged Commodities) Rules, 2011, the Food Safety and Standards (Import) Regulations, 2017 as amended and the General notes to Chapter I regarding Import Policy of ITC (HS) Classification of Export and Import Items 1997-2002 as updated is mandatory to be complied with. It is observed that the same are not fully complied in as much as necessary documents are not uploaded in e-sanchit. This is leading to unnecessary query by Customs officers and delay in customs clearance.

3.1 The importers are required to register themselves with appropriate authority under above mentioned Rules. That following declarations are also required to be given on retail packages of all imported pre-packaged commodities: -

- i. Name and address of manufacturer / packer & manufacturer (if manufacturer is not packer)/importer,
- ii. Country of origin if imported
- iii. Common, generic name of the commodity
- iv. Net qty. in std. Unit of W or M or no. of commodity in the package
- v. MRP incl. of all taxes
- vi. Unit sale price (w.e.f. 01.10.2022)
- vii. Month and year of manufacture
- viii. "Best before or use by date, month and year" in case of commodity becoming unfit for human consumption with time
- ix. Consumer Care details

3.2 Further, registration certificate under Legal Metrology (Packaged Commodities) Rules, 2011 is required to be obtained and uploaded in e-sanchit.

4. All Importers, Customs Brokers, Members of Trade and all concerned are advised to upload declarations printed on all imported pre-packaged commodities to the extent mentioned at para 3.1 above in e-sanchit. This will help customs in expeditious clearance of shipments and reduce dwell time.

3. Difficulties faced, if any, may be brought to the notice of the undersigned at the earliest.
