World Trade Up by 22% in the 1st Quarter of this Year


The value of world merchandise trade was 22% higher in the first quarter of 2011 compared to the same period of 2010, according to WTO figures released on 1 June 2011.

These short-term "value" figures should not be confused with the annual trade growth figures headlined in the 7 April 2011 press release, which are "volume" data using "constant dollars" with inflation taken into account.

Moreover, WTO short-term merchandise trade values are not seasonally adjusted. Seasonal patterns therefore considerably affect the quarter on quarter (Q-o-Q) and month on month (M-o-M) developments in world trade, and this in turn affects comparisons between the trade developments in individual regions and economies.

Trillion dollars




Available monthly statistics for about 70 economies representing more than 90% of world trade show that merchandise trade rose sharply in March 2011, reflecting in

good part seasonal variations. The value of trade reached for the first time a level superior to the pre-crisis maximum of July 2008.



Dollar Exports Up by 34% in April 2011

Exports (including re-exports)

India's Exports during April, 2011 were valued at US \$ 23849.32 million (Rs. 105819.43 crore) which was 34.42 cent higher in Dollar terms (34.03 per cent higher in Rupee terms) than the level of US \$ 17742.13 million (Rs. 78951.58 crore) during April, 2010.

Imports

India's Imports during April, 2011 were valued at US \$ 32834.36 million (Rs. 145686.06 crore) representing a growth of 14.13 per cent in Dollar terms (13.79 per cent in Rupee terms) over the level of imports valued at US \$ 28770.06 million (Rs. 128025.31 crore) in April, 2010.

Crude Oil and Non-Oil Imports

Oil imports during April, 2011 were valued at US \$ 10185.9 million which was 7.7 per cent higher than oil imports valued at US \$ 9454.0 million in the corresponding period last year.

Non-oil imports during April, 2011 were estimated at US \$ 22648.4 million which was 17.3 per cent higher than non-oil imports of US \$ 19316.0 million in April, 2010.

Trade Balance

The trade deficit for April 2011 was estimated at

US \$ 8985.0 million which was lower than the deficit of US \$ 11027.9 million during April 2010.

for land and water, and creeping climate change." The poorest people of the world, who spend more than 80 percent of their income, will be the hardest hit, Oxfam says. The development-focussed NGO says policy changes, such as limiting speculation on food commodities and scrapping support for biofuels made from food crops, will help combat the problem.

Euro Hits One-Month High

The euro touched a month high versus the dollar on prospects officials from the European Union will reiterate their intention to prepare a new aid package for Greece, easing concern over the region's debt crisis.

Demand for the single currency was supported before a report that may show producer-price inflation in the trading bloc held near a 2-1/2 year high in April, backing the case for the European Central Bank to increase borrowing costs. The dollar traded 0.3 percent from a one-month low versus the yen as signs of moderating U.S. growth add to the case for the Federal Reserve to keep interest rates near zero.

The euro climbed as high as \$1.4658, the strongest since May 5, before trading at \$1.4639 from \$1.4635 in New York on June 3. The 17-nation currency was at 117.51 yen from 117.48. The dollar bought 80.27 yen from 80.34 yen last week, when it touched 80.05, the weakest since May 5.

The euro was the biggest winner last week against nine other currencies of developed nations measured by the Bloomberg Correlation-Weighted Indexes. It rose 1.6 percent, followed by a 1.2 percent gain in the Swiss franc and a 1.1 percent advance in the Norwegian krone.

DEPB Extension under Discussion with Fin Min, says Sharma

Commerce Minister Anand Sharma said that the issue of extension of DEPB and re-introduction of interest subvention is being discussed with the Finance Minister and he assured the exporter that their concern will be adequately addressed.

Commerce Minister announced that from today zonal office of DGFT will provide time bound clearances and this will be quarterly audited. Mr Sharma said that he is attempting discharge of Export Obligation electronically so that voluminous document and delays are eliminated. Mr Anand Sharma said that he will review the delays in imposition of provisional anti dumping duty so that the same can be imposed in reasonable time compared with best practices. For providing commercial information to Indian exporter, Mr Sharma agreed to strengthen commercial Missions abroad and open more such missions. Mr Sharma said that new manufacturing policy shall be announced shortly aiming to increase share of manufacturing in GDP from 16% to 25%.

India Notifies Higher ASEAN Duty for Philippines

The current notification 46-Customs dated 01 June 2011 supersedes notification 153-Customs dated 31 December 2009

Ntnr 46 In exercise of the powers
01.06.2011 conferred by sub-section (1)
(DoR) of section 25 of the Customs
Act, 1962 (52 of 1962), and in
supersession of the notification of the Government of India, in the Ministry of Finance (Department of Revenue), **No. 153/2009-Customs dated the 31st December, 2009 [G.S.R. 944 (E), dated the 31st December, 2009]**, except as respects things done or omitted to be done before such supersession, the Central Government, being satisfied that it is necessary in the public interest so to do, hereby exempts goods of the description as specified in column (3) of the Table appended hereto and falling under the Chapter, Heading, Sub-heading or tariff item of the First Schedule to the Customs Tariff Act, 1975 (51 of 1975) as specified in the corresponding entry in column (2) of the said Table, from so much of the duty of customs leviable thereon as is in excess of the amount calculated at the rate specified in,-

column (4) of the said Table, when imported into the Republic of India from a country listed in APPENDIX I; or column (5) of the said Table, when imported into the Republic of India from a country listed in APPENDIX II .

Provided that the importer proves to the satisfaction of the Deputy Commissioner of Customs or Assistant Commissioner of Customs, as the case may be, that the goods in respect of which the benefit of this exemption is claimed are of the origin of the countries as mentioned in Appendix I, in accordance with provisions of the **Customs Tariff [Determination of Origin of Goods under the Preferential Trade Agreement between the Governments of Member States of the Association of Southeast Asian Nations (ASEAN) and the Republic of India] Rules, 2009**, published in the notification of the Government of India in the Ministry of Finance (Department of Revenue), No. 189/2009-Customs (N.T.), dated the 31st December 2009.

Declaration of Intent Mandatory on Free Shipping Bills for Claiming Reward Scheme Chapter 3

Subject: Clarification about requirement of "Declaration of Intent" on Free Shipping Bills for claiming Chapter 3 scheme benefits.

32-Pol.Cir Para 3.11.8 of HBPv1 2009-14 (earlier Para 3.23.8 in 03.06.2011 RE-2008) provides for "Declaration of Intent" to be (DGFT) made on "free shipping bills" in order to claim Chapter 3 benefits.

2. It is clarified that "Declaration of Intent" needs to be mentioned mandatorily on the free shipping bills for claiming Chapter 3 benefits. This declaration can be made in the product description column in the free shipping bills where sufficient space is available for this purpose. Instances have also been reported where free shipping bills bear only the name of the Chapter 3 scheme like FPS, FMS etc or the intention to claim Chapter 3 benefit has been mentioned manually on the shipping bills duly attested by customs. In such cases RA's will accept these shipping bills for grant of Chapter 3 benefits.

3. The "Declaration of Intent" would not be required for shipments filed under chapter 4 (including drawback), chapter 5 or chapter 6 of FTP.

4. All RAs to take suitable action accordingly.
5. This issues with approval of DGFT.

2. The amended para 3.11.8 will now read as:

"Export shipments filed under the Free Shipping Bill category, would need the following declaration on the Shipping Bills in order to be eligible for claiming chapter 3 benefits of FTP :

'We intend to claim chapter 3 benefits.'

This declaration shall not be required for export shipments under any of the schemes of Chapter 4 (including drawback), Chapter 5 or Chapter 6 of FTP.

If there is a decision during the year to include any new product or new market to avail such benefit, then:

(i) For exports of such products/ export to such markets, a grace period of one month from the date of decision/ notification/public notice will be allowed for making this declaration of

intent on free shipping bills.

(ii) After the grace period of one month, all exports (of such products or to such markets) would have to include the declaration of intent on the free shipping bills.

(iii) For exports made prior to date of decision/notification/public notice of products/markets, such a declaration will not be required since such exports would have already taken place."

Effect of this Public Notice

Till now Shipping Bills filed under Chapter 4 (including drawback), Chapter 5 or Chapter 6 schemes needed a "Declaration of Intent" for claiming chapter 3 benefits. Now this "Declaration of Intent" is required only on Free Shipping Bills for claiming Chapter 3 benefits.

DTAA between India and Mozambique Notified

The Government of India notified the Double Taxation Avoidance Agreement (DTAA) with the Government of Mozambique for the avoidance of double taxation and for the prevention of fiscal evasion with respect to taxes on income on 31st May, 2011.

The DTAA provides that business profits will be taxable in the source state if the activities of an enterprise constitute a permanent establishment in the source state. Examples of permanent establishment include a branch, factory, office, place of management, etc. Profits of a construction, assembly or installation projects will be taxed in the state of source if the project continues in that state for more than 12 months.

Profits derived by an enterprise from the operation of ships or aircraft in international traffic shall be taxable in the country of residence of the enterprise. Dividends, interest and royalties income will be taxed both in the country of residence and in the country of source. However, the maximum rate of tax to be charged in the country of source will not exceed 7.5% in the case of dividends and 10% in the case of interest and royalties. Capital gains from the sale of shares will be taxable in the country of source.

The DTAA further incorporates provisions for effective exchange of information and assistance in collection of taxes between tax authorities of the two countries in line with internationally accepted standards including exchange of banking information and incorporates anti-abuse provisions to ensure that the benefits of the Agreement are availed of by the genuine residents of the two countries.

The DTAA will provide tax stability to the residents of India and Mozambique and facilitate mutual economic cooperation as well as stimulate the flow of investment, technology and services between India and Mozambique.

Mr Deora urged C&IM that DEPB Scheme should be extended till GST becomes operational or at least till the end of the Financial Year.

President FIEO also suggested host of measures to reduce transaction cost of exports which ranges between 7- 10% of exports value. He referred to long delay which takes place in ratifying the Norms for Advance Authorization issued under Paragraph 4.7 on self declaration basis where SION does not exist.

President FIEO raised concern on the delays and paperwork involved in closure of advance authorization at DGFT and same procedure should be followed at Customs.

FIEO President asked the Government to implement full EDI connectivity amongst the agencies involved in Import/Exports for a seamless movement of cargo which can only help in reducing transaction time and cost to a large extent.
