Subject: - Addendum to Public Notice No. 26/2019 dated 11.11.2019 for Mandatory uploading of import documents in e-sanchit – reg.


Kind reference is invited to Public Notice No.26/2019 dated 11.11.2019 vide which attention of all Importers, Custom Brokers, Custodians, Members of the trade and other stake holders was invited to Bill of Entry (Electronic Integrated Declaration and paperless processing) Regulations, 2018 issued vide Notification No. 36/2018-Customs(N.T.) dated 11.05.2018 and Public Notice No. 22/2019 dated 26.09.2019 issued by this Commissionerate.

2. In continuation to the above, it may be noted that the effective date of mandatory uploading of documents in e-sanchit has now been extended from 15.11.2019 to 05.12.2019. Therefore, the date of mandatory uploading of Invoice and Bill of Lading in e-sanchit for every Bill of Entry and subsequent declaration of document code and IRNs in the BoE will become effective from **05.12.2019**.

3. Action to be taken in terms of this Public Notice should be considered as Standing Order for compliance by the officers and staff posted in ACC(Import) Commissionerate.

4. Difficulties faced, if any, may be brought to the notice of Deputy Commissioner of Customs, ACC Import Shed, New Delhi.
