Preamble:

The global electronics industry, driven by accelerating digitization, is one of the fastest-growing sectors and plays a foundational role in economic and technological advancement. As electronics has cross-cutting impact across various sectors, it holds strategic significance in influencing and enabling progress of the economy.

With a view to enhancing India's position in electronics Global Value Chains (GVCs), and to foster domestic component and sub-assembly manufacturing, Government of India notified the Electronics Component Manufacturing Scheme vide Gazette Notification read at Sr. no. 1. This would not only increase Domestic Value Addition (DVA) but also increase export and reduce import dependency.

The focus is on localization/ indigenisation of strategic/ critical products within the Electronics System Design and Manufacturing (ESDM) value chain in the country. Given the strategic importance of electronic components, the Government of Gujarat (GoG) has been actively considering boosting component manufacturing in the State. Government of Gujarat is committed to the vision of the Government of India (GoI) laid down in the recently introduced Electronics Component Manufacturing Scheme read at Sr. no. 1.

Resolution:

After detailed deliberations, the Government of Gujarat has resolved to support electronics component manufacturing in the State in synergy with the Government of India Scheme. This resolution will be known as **Gujarat Electronics Component Manufacturing Policy**. This resolution will provide supplementary support for electronics component manufacturing in synergy with the Electronics Component Manufacturing Scheme notified by Government of India read at Sr. no. 1 and the subsequent Guidelines of Government of India read at Sr. no. 2 for the operation of the Electronics Component Manufacturing Scheme, as amended from time to time.

1. Gujarat Electronics Component Manufacturing Policy:

1.1. Definition

For the implementation of this policy the definitions as per the Electronics Component Manufacturing Scheme (ECMS) vide Government of India's Gazette Notification No. CG-DL-E-08042025-262341 dated 08/04/2025 and the subsequent Guidelines for the Operation of the Electronics Component Manufacturing Scheme dated 26/04/2025, as amended from time to time, will be adopted.

1.2. Eligibility

Eligibility criteria will be as below-

- i. The project proposals of the applicant must have received approval from the Competent Authority under the Electronics Component Manufacturing Scheme of MeitY, GoI; and
- ii. The applicant must be in the process of/ has proposed to establish the manufacturing unit in Gujarat.

Upon fulfilment of these conditions, the application will be submitted to the State Level Empowered Committee (SLEC) and/or High Powered Committee (HPC), as applicable, as defined in Section 4.3 and Section 4.2 respectively of the Gujarat Electronics Policy (2022–28) read at Sr. no. 3, for approval. However, the member at Sr. No. 3 of State Level Empowered Committee (SLEC) and member at Sr. No. 9 of High Powered Committee (HPC) will be replaced by Additional Secretary (E & T) / Joint Secretary (E & T) / Deputy Secretary (E & T), Department of Science & Technology.

1.3. Incentives

It is resolved that eligible units engaged in manufacturing of electronics components as per the definition will be supported as per the provisions under this Policy. Units availing incentives under this policy will not be eligible for assistance under Gujarat Electronics Policy (2022–28) read at Sr. no. 3 and vice-versa.

The Government of Gujarat will support the eligible units with matching incentives as described under Annexure A(II), subject to satisfying the Threshold Criteria as described in Annexure A(III) of the Government of India's Electronics Component Manufacturing Scheme read at Sr. no. 1.

2. Additional Stimulus

In addition to the incentives outlined in Section 1.3 of this Resolution, it is hereby further resolved that the following additional stimulus shall be extended to eligible applicants under this Scheme:

- **Workforce Development Credits:**

The Government of Gujarat (GoG) shall provide matching financial support equivalent to the investment made by the Project Proponent for the establishment of a Lab, Finishing School, or Centre of Excellence (CoE) in any of the academic institutions in Gujarat, as approved by GSEM/Department of Science & Technology. The project cost shall be capped at ₹25 Crore for consideration, with maximum financial support of ₹12.50 Crore from the Government of Gujarat.

- **Common Infrastructure & Logistics Facilities:**

The Government, through any of its agencies, will augment and strengthen existing infrastructure for electronics component manufacturing sector through development of common infrastructure & logistics facilities in the electronics clusters on need basis.

3. Support Duration

Support duration of this Policy will be same as that of Government of India's Electronics Component Manufacturing Scheme read at Sr. no. 1.

4. Policy Implementation

Office of the Mission Director, Gujarat State Electronics Mission (GSEM), Department of Science and Technology, Government of Gujarat will be the Nodal Agency for implementation of this policy.

Any project availing financial support under this policy shall not be eligible to receive benefits under any other policy notified by the Government of Gujarat aimed at incentivizing industrial development.

5. Scrutiny

To promote Ease of Doing Business in the state, minimal required subsequent scrutiny will be undertaken by Gujarat State Electronics Mission (GSEM) for applications approved under the Electronics Component Manufacturing Scheme by Government of India read at Sr. no. 1.

6. Disbursal of Incentive

Mechanism for disbursal of incentives by GSEM will be same as per the Guidelines for the Operation of the Electronics Component Manufacturing Scheme dated 26/04/2025 issued by Government of India. Disbursal of incentives by the State will be on Annual Basis in proportion to the amount approved and disbursed by Government of India, within 30 working days of successful submission of the claim to GSEM with required documents, following incentive disbursement by Government of India.

7. Interpretation

The Department of Science and Technology, Government of Gujarat is authorized for interpretation of any provision and to give clarification/ decision with reference to any provision under this resolution, keeping in view the objective of the Policy and scheme, and it will be final and binding to all concerned.

8. Authority to Amend

Notwithstanding anything contained in the foregoing paras, the Government reserves the right to review and amend any aspect of the Policy from time to time.

9. Budgetary Provision

The expenditure on this account shall be made from the grants under the following budget head:
