Subject: Reinstatement and amendment in Standard Input Output Norms (SION) C676 for export of "HOT DIPPED GALVANISED TENSION BAR/ GATE RODS/ TRUSS RODS/ DROP RODS".

In exercise of powers conferred under Paragraph 1.03 of the Foreign Trade Policy 2023, as amended from time to time, the Director General of Foreign Trade hereby reinstates and amends the suspended Standard Input Output Norms (SION) C676 for export of "HOT DIPPED GALVANISED TENSION BAR/ GATE RODS/ TRUSS RODS/ DROP RODS" as under:
